

CWATS Photo Contest Rules

The County of Essex is conducting an online photo contest and awarding a series of small prizes randomly to entrants who qualify.

To qualify for the draw, entrants must post a photograph of themselves and/or others cycling, walking or using other forms of active transportation in Essex County, Ontario. Participants must abide by all public health guidelines. Posts should include a brief description of why the participant likes to "Walk, Ride, County-Wide" and must include the hashtag #CWATS.

Photos, descriptions and hashtags must be posted on Facebook, Twitter or Instagram using the hashtag #CWATS or submitted through the contest submission page.

Potential winners will be notified by social media, email or telephone based on information provided by the entrant.

This contest is subject to the laws of Ontario and the federal laws of Canada as may be applicable.

Chances of winning depend on the number of eligible entries received.

The County of Essex is not responsible or liable for entries that are lost, not approved, destroyed or deleted. There is also no responsibility or liability for any potential entrant's inability to access the survey for contest entry.

The County of Essex is not responsible for any typographical, production or online errors that may occur during the draw or in any material either printed or online.
